**I command you to send me the Labourcontract for PrimeMinister, by return mail.**

It must be an exact copy of the labourcontract of Markrutte.  
You add an Introduction, text:

- DesireeElisabethStokkel will be InterimPrimeMinister next to Markrutte.
- Markrutte – King Willem-Alexander can stay in charge untill 17march2017.
- The House of Representatives and the Senate will not put laws into power from today untill 17march2017.
- The Parliament will turn itself into a Business-parliament anchored in the Constitution Republic NL. Founded political parties need 4 months to remove dictators from the party.
- The people will build new laws in the RepublicNL, anchored in the Arbitration-court-system as listed in the Constitution RepublicNL.
- DesireeStokkel will observe the conduct of the Constitution RepublicNL and the 3 above mentioned laws, from her Galaxy-office.

### **What does this mean?**
